AN ORDINANCE FOR THE LEVY AND ASSESSMENT OF TAXES
FOR THE FISCAL YEAR BEGINNING MAY 1, 2017
AND ENDING APRIL 30, 2018

BE IT NOW AND HEREBY ORDAINED by the President and Village Board of Trustees of the Village of Hinckley, DeKalb County, Illinois that:

SECTION 1. As set forth in an Appropriations Ordinance adopted on July 17, 2017, the total amount of appropriations for all corporate purposes, except for tax increment financing districts and debt service funds, legally made to be collected from the tax levy of the current fiscal year is hereby ascertained to be the sum of Five Hundred Five Thousand dollars (\$505,000.00) which amounts have been appropriated for the following purposes: Corporate Fund, Police Protection, Illinois Municipal Retirement, Social Security, Liability Insurance/Tort (Judgements), Municipal Auditing, School Crossing Guard, Workers Compensation and Unemployment Insurance for the fiscal year beginning May 1, 2017 and ending April 30, 2018. The specific amounts as appropriated for the various purposes are as follows:

SECTION 2. That the sum of Five Hundred Dollars (\$500.00) being the total amount appropriated and such amounts thereof which are to be collected from the tax levy of the current fiscal year beginning May 1, 2017 and ending April 30, 2018 as set forth below in Section 4, of the Village of Hinckley for the following purposes: Hinckley Special Service Area #1 as follows:

SECTION 3. That the sum of Five Hundred Dollars (\$500.00) being the total amount appropriated and such amounts thereof which are to be collected from the tax levy of the current fiscal year beginning May 1, 2017 and ending April 30, 2018 as set forth below in Section 4, of the Village of Hinckley for the following purposes: Hinckley Special Service Area #2 as follows:

A. Special Service Area #2 \$ 500.00

SECTION 4. There is hereby levied upon all taxable property within the corporate limits of the Village of Hinckley, Illinois, as the same is assessed and equalized for State and County taxation, for the fiscal year beginning May 1, 2017 and ending April 30, 2018, the sum of Two Hundred Seventy-Three Thousand Four Hundred Ninety dollars (\$273,490.00), or so much thereof as may be authorized by law, the same being itemized as follows:

C.	Police Protection	\$ 43,200.00
D.	Audit	\$ 9,600.00
E.	Tort (Judgements) Fund	\$ 9,790.00

G.	School Crossing Guards	\$ 6,750.00
H.	Workers Compensation	\$ 13,100.00
I.	SSA# 1	\$ 450.00
J.	SSA# 2	\$ 460.00

SECTION 5. That this Levy Ordinance is adopted pursuant to the procedure set forth in the Illinois Municipal Code.

SECTION 6. That there is hereby certified to the County Clerk of DeKalb County Illinois the several sums aforesaid constituting the total amount of Two Hundred Seventy Three Thousand Four Hundred Ninety dollars (\$273,490.00) which total amount the Village of Hinckley requires to be raised by tax levy for the fiscal year beginning May 1, 2017 and ending April 30, 2018 of the Village and the Village Clerk of the Village is hereby ordered and directed to file with the County Clerk of DeKalb County, a certified copy of this Ordinance on or before the time required by law.

SECTION 7. That all other orders, resolutions or ordinances in conflict herewith are hereby repealed insofar as such conflict exists, and this Ordinance shall take effect ten (10) days after its passage, approval and publications, as provided by Law.

SECTION 8. That the Village Clerk is hereby authorized to publish this Ordinance in pamphlet form.
